# Snapshot of Community Engagement Initiatives March 2023 to April 2023

## GO PURPLE DAY – 28th April 2023

The Go Purple Day initiative is an annual campaign whereby An Garda Síochána has partnered with domestic abuse support services to help raise awareness about domestic abuse and the local domestic abuse support services available to those affected by domestic abuse in Ireland. The purpose of the initiative is to help strengthen community partnerships between domestic abuse services and An Garda Síochána, has developed into what is now a national day in respect of domestic abuse awareness.

This year's Go Purple Day, led by An Garda Síochána and the Garda National Protective Services Bureau (GNPSB), took place on the Friday, 28th April 2023.

This is an excellent opportunity to celebrate and highlight the ongoing engagement between local Gardaí and their respective domestic abuse services and to reaffirm the message that help, reassurance and support is available to victims of domestic abuse.
