To whom it concerns,



The relevant land is not serviced. The provision of services depends on the development of the adjacent lands (planning permission reference ) which is in separate ownership and outside of our control.


We enclose a map of the relevant lands with our property outlined blue. Proof of ownership if required can be supplied upon request
