### Community Recognition Fund 2024

Clare County Council was awarded €2,608,408 under the Community Recognition Fund 2024. This fund is specifically targeted at projects that are located in towns and villages that are hosting the Beneficiaries of Temporary Protection and/or International Protection Applicants. A total of 20 projects were approved for funding under Window 1 of the scheme, totalling €1,702,000.

The following 4 projects have been successfully completed, enhancing local amenities and community facilities.

### St Joseph's National School Miltown Malbay

With a grant of €120,000, St Joseph's National School has completed the construction of:

- An outdoor classroom area, providing students with a dynamic learning space.
- An outdoor exercise area, promoting physical activity and well-being.
- A tarmac walkway, improving accessibility around the school grounds.
- A biodiversity sensory garden, fostering environmental awareness and engagement.
- Picnic benches, creating a social space for students and visitors.

These enhancements have significantly improved the school's outdoor learning and recreational facilities and are open and available for the enjoyment of the wider community.



### Twin Wells, Lisdoonvarna

Lisdoonvarna Fáilte utilised €125,000 in funding to complete a landscaping project at the Twin Wells, a site of local cultural and historical importance. The project has improved the site's aesthetics, accessibility, and visitor experience, preserving it as a key community landmark.



### St Senan's RFC Shannon

St Senan's Rugby club in Shannon successfully upgraded its floodlighting system with a €50,000 grant. The improved lighting enhances visibility and safety for training sessions and matches, benefiting players of all ages and supporting the club's continued development.



### Shannon Leisure Centre

With €50,000 in funding, Shannon Leisure Centre has replaced its Cardio gym equipment, which enhances user experience by ensuring modern, high-quality fitness facilities for the local community.

### Launch of Healthy Clare Micro Fund 2025

Healthy Clare launched the 2025 Healthy Clare Micro Fund on the 13th February 2025.

The Healthy Clare Micro Fund supports community and voluntary groups wishing to undertake specific 'Health and Wellbeing' projects under the relevant categories of the fund. The purpose of the Local Community Development Committee's Healthy Clare Micro Fund is to encourage and support community and voluntary groups to take an active part in improving and protecting health and wellbeing at all stages of life, reducing health inequalities, and creating an environment where everyone can play their part in a healthier Clare.

The purpose of the fund is to improve population Health and Wellbeing in County Clare, by supporting and encouraging targeted actions in response to the identified 2 priority outcomes needed for a Healthier Clare. The Healthy Clare Micro Fund is supported by the Department of Health's Healthy Ireland Fund, Pobal and Creative Ireland Clare.

The Healthy Clare Micro Fund comprises of 4 different support funds

1. Support Fund for promoting a Healthy Weight (Max Grant €2,000 per application)
2. Support Fund for promoting Positive Mental Health (Max Grant €2,000 per application)
3. Creative Ireland Funding, through Healthy Clare to promote Healthy Weight projects, delivered through creative mediums. (Max Grant €500 per application)
4. Creative Ireland Funding, through Healthy Clare to promote Positive Mental Health projects, delivered through creative mediums. (Max Grant €500 per application)

### Right to Read/ Adult Literacy for Life

Ireland Reads Day on 22nd February is led by Libraries Ireland to encourage people of all ages to pick up a book during February and to embrace the pure joy and power of reading. Events included the launch of the book *Glór Naomh Brid* with a talk on the song repertoire of the late Jamesie McCarthy (1898-1977) in The Carroll Mackenzie Collection in Clare County Library Archives. Copies of the book will be donated to Clare Libraries and Clare primary schools. A sensory Play workshop with Maia Purposeful Play was held in Miltown Malbay Library and a STEAM Paper sculptures and geometric shapes building workshop in De Valera Library. An interview with Ukrainian author Serhii Adamenko, was held in association with Ennis Book Club Festival and the Ireland Against Racism Fund in De Valera Library.

### Healthy Ireland

There were five 5 Healthy Ireland events this month. Trish Cleary, yoga teacher, facilitated 4 online Chair Yoga events, which were attended by people in nursing homes, day care centres and individuals in their own homes. There was a total attendance of 89 people. A total of 20 people attended a journaling for mental health workshop facilitated by Mid-West ARIES, in De Valera Library. Mid-West ARIES offers a range of courses, together with information and educational materials on Recovery and Well-being.

### Local Studies



Merriman event

The Local Studies Centre has received papers containing compositions by the musician and composer Ernest De Regge, donated by his daughter Ghislaine. De Regge was the music professor at St. Flannan’s College, an organist-choirmaster in Ennis Cathedral, and broadcaster on Radio Éireann and the BBC. The Local Studies Librarian was interviewed on Clare FM about Paddy Hannan, who emigrated from Quin and later discovered the goldfields in Kalgoorlie Australia. A collection of Church of Ireland Glebe maps has been digitised and are available in the library. The Crusheen Active Retirement group visited De Valera Library. The group learned about services and resources available at the library and were delighted to visit the Local Studies section where they perused an edition of *The Clare Journal* from 1897. Work on the Local Studies Website upgrade is ongoing.

### Clare Archives

The latest tranche of Ennistymon Board of Guardians records was uploaded to the Digital Repository of Ireland with files going live week ending 21st February. The archivist is progressing archival

queries (approx. 25 archival requests per month) and general cataloguing. The archivist assisted in the Brian Merriman and Cumann Merriman launch and talk as Gaeilge regarding archives and Local Studies holdings.

### Clare Arts Office

Four support meetings were held with artists and Arts office staff also attended meetings and webinars regarding the Creative Places Programme in Shannon. The Arts office adjudicated on the LEO Student Enterprise Awards, the Engine Short Film Scheme and over 80 CLAGS applications.

Staff in the Arts Office assisted with film enquiries regarding an international casting call, an Apple TV documentary and enquiries for local crews and supported a short film shot in Ennistymon.

Three films were shown in Culturlann Sweeney, Kilkee as well as an exhibition event. Two Arts in Clare slots happened on Clare FM.

The Arts in the Community programme continued in St. Joseph's Hospital, Ennis and in Raheen Hospital. Three groups of Clare Youth Theatre continued to meet weekly. The Arts Office completed the first stage of the consultations for the new arts plan via online survey. A total of 113 people engaged initially and follow on consultations are in progress. Three Embrace (Arts & Disability) residencies commenced with the Irish Wheelchair Association, the Brothers of Charity and Ennis Voices for Autism.

Three exhibitions took place in Clare Museum, Scariff Gallery and Culturlann Sweeney. Súil's inaugural exhibition, *The Art of Place*, came to a close and the photographs by John Kelly have been catalogued and added to the county art collection. *Líníocht: A Selection of Works From The National Collection of Contemporary Drawing* which features over 60 works by Irish artists, generously loaned by the Limerick City Gallery of Art runs until March 27th and has welcomed over 400 visitors since its opening on February 7th.

### Clare Museum

Plans are progressing to host a Polish Festival at the Museum. The festival will include an art exhibition, film screenings, Polish crafts workshops and much more. There were 18 people at the monthly lecture series on "Ancient Grains" with Dr Meriel McClatchie of UCD this month.

The Curator and Education Officer visited St. Caimin's secondary school in Shannon, where the curator gave talks to two classes on the Museum. There were approximately 70 students in attendance altogether. The Museum submitted an application for the Heritage Council's Heritage Stewardship funding. The funding is being sought to develop a public access VR exhibition based on the existing John Philip Holland exhibition in the museum. The Museum hosted 8 individual workshops for primary schools, facilitated by local storyteller, Ruth Marshall. Over 225 children, along with their various teachers attended the workshops and learned all about St. Brigid, the Celtic goddess and Christian saint, the many different styles of Brigid's cross, and about the origins, folklore and traditions of the cross (crios), and the cloak. The Curator visited Bridgetown NS in O'Briensbridge to give a talk on the museum and artefacts. The visit was requested by the school as part of their own Museum Week.

The Museum's Education Officer held a competition for TY students from Rice College in their school. This is the first time that County Clare has participated in the nationwide ARTiculation competition, following an invite to do so from the organising museum, Tipperary Museum of Hidden History. As part of the competition students chose a piece of art and/or architecture and gave a 10-minute presentation on their chosen topic. The top two students will go forward to the All-Ireland final in April to represent Co. Clare.

## KILLALOE MD

### Killaloe - Ballina Town Enhancement and Mobility Strategy

#### Pedestrianisation Trial for Killaloe Bridge

Following an engagement with a range of stakeholders in January and February by officials from Clare and Tipperary County Councils, both local authorities have agreed to pedestrianise the existing Killaloe Bridge for a trial period.

The trial, provided for under Section 38 of the Road Traffic Act 1994, aims to pilot a more pedestrian and cyclist-friendly route on the existing bridge between Killaloe and Ballina. The trial will also enable further detail and evidence of traffic flows and pedestrian movements between the towns to be gathered, and for the social, economic and tourism benefits to be measured.

The timeline for the trial will be announced closer to the opening of the new Killaloe Bypass bridge.




#### RRDF Application

In the meantime, Clare County Council is leading the preparation of a significant joint Rural Regeneration and Development Fund (RRDF) application, along with Tipperary County Council, for the commencement of the detailed design and feasibility of a number of projects and improvements to the public realm in Killaloe and Ballina under the Killaloe-Ballina Town Enhancement and Mobility Plan.

Work continued in February on the preparation of an RRDF application on behalf of Clare County Council and Tipperary County Council for the enhancement of the public realm and a number of town centre economic development and tourism opportunity developments. The focus in February was undertaking background economic appraisals to assist in the preparation of the funding application. In addition a number of community groups and stakeholders were met.

It is anticipated that an application for RRDF Funding will be made on or before 14th March.



#### Crusheen

#### Crusheen Mobility Plan

The focus of work in February was on collating and examining views from the local community on Ideas and Emerging Options for the Crusheen Mobility Plan, following an on-line survey. Presently Killaloe MD are examining options with a view to having a Draft Crusheen Mobility completed in March. It is anticipated that a public consultation event of the Draft Mobility Plan will take place in Crusheen early March.

#### Reopen Crusheen Railway Station

During February, further engagement with Killaloe MD and Irish Rail took place advocating the reopening of the Crusheen Railway Station. In addition the Senior Planner, Cathaoirleach of the MD and a number of other Elected Members attended an Irish Rail Briefing on regional rail development projects in the Mid-West Region and further highlighted the merits of reopening Crusheen Railway Station on the Western Rail Corridor.

#### RRDF Application for Crusheen

An RRDF Application for the development of feasibility studies, plans and project development of a transformative town centre project is underway. The proposed RRDF Application will seek to reopen Crusheen Railway Station on the Western Rail Corridor, undertake public realm enhancement in line with the Crusheen Mobility Strategy and develop a Multipurpose Community Enterprise Hub and Crechce. The project - a key objective of the recently launched "Elected Members Killaloe - Workplan and Strategy" - follows significant background studies, assessment and engagement with the community over the last 18 months and in particular engagement by the Elected Members and Senior Planner of the MD with Irish Rail.



### Canoe trail, Slalom Course and Whitewater rafting centre on the River Scarriff

In February Killaloe MD, in collaboration with East Clare Paddlers, Canoeing Ireland and a number of other community, sporting and disability organisations sought funding under the Outdoor Recreation Improvement Scheme (ORIS) for a proposed Canoe trail, Slalom Course and Whitewater rafting centre on the River Scarriff.

Funding is sought for detailed Design of a Canoe trail, Slalom Course and Whitewater rafting centre on the River Scarriff. Access for All users to the river will be a via a proposed riverside trail on Local Authority owned lands adjoining the river and linking Scarriff town to an existing riverside walking trail.

This ORIS Project Development Measure (PDM) seeks to give effect to the number of local, County and Regional Planning and Tourism Strategies to develop a canoe/kayak facility at this location on the R.Scarriff and to enhance 'Access for All' and use-ability of the waters in the Lough Derg catchment.

### Outdoor Works

Works continue in Kilkishen Village, with 215m of new footpaths under construction from Hillcrest grove to the L-3016 Junction with the R-462, works expected to be completed on site over the next 2 to 3 weeks.

The works will also involve a new 225mm surface water pipeline, improvement have also been made to the street lighting with with two additional streetlights installed as part of the scheme

### Clare County Council Housing Grants online application



The Allocations Team are currently assessing the expressions of interest received and this process should be completed within the next 2 weeks.



### Housing Allocations

Clare County Council continues to work with the Approved Housing Bodies (AHB's) in relation to the delivery of social housing. The Allocation process in relation to phase 3 of the new social housing development located at Acha Bhile, Lahinch Road Ennis is completed, and the nominated households have been forwarded to Cluid Housing. This development is delivered by Cluid Housing and comprises 10 no 3 bedroomed houses. In addition, phase 2 of the social housing development located at Moyard, Shanballa, Ennis comprising 18 units was recently advertised on the CBL website. Almost 400 expressions of interest were received which the Allocations Team are currently assessing. This development is delivered by Tuath Housing. The new social housing development comprising of 7 no



### Tenant Purchase Incremental Scheme

There remains significant interest in the LA Tenant Purchase Incremental Scheme. We currently have 26 open cases at various stages of the process. The sale of seven properties under the tenant purchase scheme completed in 2024. Two properties have been sold in February 2025. It is expected that more sales will complete in March 2025.



There are 143 RAS, 215 leases (120 Long term and 95 short term leases) There are 1058 HAP tenancies. Approved Housing bodies are providing approximately 1,080 tenancies to Social Housing Applicants. Clare County Council have full nomination rights in respect of the majority of AHB properties and these properties are advertised via our Choice Based Letting System. Nominations are prepared in accordance with a new National Process agreed by LAs and the AHB sector and commenced in July 2022.

### Estate Management

The Estate Management Team continue to undertake regular routine and response calls to tenants, dealing with complaints

re breaches of Tenancy and ASB as well as inspecting Local Authority tenancies and providing the necessary supports to tenants. The team were successful in securing 3 Repossession Orders in court in 2024. A number of further Repossession Applications will be going through the Courts in the coming months.

The team continue to be extremely active in carrying out tenancy visits. It should be noted that the follow up on complaints received and the no. of visits carried out **do not correlate** with an increase in instances of anti-social behaviour or tenancy breaches but rather that a more proactive approach is being taken with the team in engaging with tenants.

### Private Rented inspections:




### Local Authority Purchase and Renovation Loan

The Local Authority Purchase and Renovation Loan was introduced on the 22 July 2024. This is a government backed mortgage and loan for the purchase and renovation of derelict and non-habitable homes. The property must be eligible for the Vacant Property Refurbishment Grant, whether derelict, non-habitable or simply vacant.

### The Homeless Action Team

The level of complex cases presenting to the Homeless Action Team in Clare has continued to increase. Additional demands are being placed on the Homeless Action Team to provide Emergency Accommodation in a safe and appropriate manner.

The levels of support, advice and advocacy, being requested from households around areas such as Homeless Services, Housing Requirements, Health supports, Outside Support referrals and the need for Emergency Accommodation within this region is increasing.

There has been a notable rise in the number of presentations of individuals and households experiencing difficulties and concerns around Hospital discharges, Prison releases, Family or relationship breakdown, addiction or mental health concerns, dual diagnosis, and a further increase in the number of households presenting from the Travelling Community.

The level of aggression being experienced by the Homeless Action Team staff and supporting agencies staff which increased in 2024 needs to be monitored and addressed in 2025.

Prevention and support remain a key factor in the workings of the Homeless Action Team. Several single and household presentations worked with staff around prevention options and supports which in turn prevented the need for Emergency Accommodation and avoiding entering Homeless services. Other individuals and families were supported in accessing Emergency Accommodation either within our services or through private establishments.

The Homeless Action Team continues to pursue additional emergency accommodation options at a time when accommodation is in high demand generally.

### Homeless Services [Homeless Action Team HAT]

Clare Homeless Action team continues to engage with all necessary stakeholders, service providers and local supports to adopt a collaborative approach to the tackling of Homelessness.

### Affordable Housing Schemes for County Clare

CCC continue to run Expression of Interest (EOI) Campaigns seeking proposals on options to deliver affordable homes in County Clare. CCC are also engaged with developers with potential for Part V affordable delivery.

To date, CCC have received approvals for access to the Affordable Housing Fund for the following developments:

- Tulla Rd Ennis - 10 units.
- Lahinch Rd Ennis - 11 units
- Shannon - 10 units (3 units allocated)

The online applications portal for the homes in Shannon closed on Friday 21st February 2025, and seven successful applicants have been selected using the Council's Affordable Housing Scheme of Priorities. These clients are now engaged with the developer and their agents to finalise sales. The portal for the homes on the Lahinch Rd Ennis opened on Monday 24th February 2025, and an open evening will be held in Ennis in early March. CCC are currently engaged with 2 other developers, that have expressed interest in affordable housing, for potential inclusion on the scheme.



### Defective Concrete Blocks Grant Scheme

The Defective Enhanced Defective Concrete Blocks [DCB] Scheme went live in mid-July 2023, for private dwellings, with the finalised Act, regulations, updated YQA's (Your Questions Answered) & Ministerial Guidelines published.

On the 7th of November 2024, The Minister approved an increase in the grant cap from €420,000 to €462,000.

**DCB Application Map**





Applications to the scheme can be submitted on-line through CCC’s website. The website includes supporting information to further assist homeowners regarding the application process. Clare County Council DCB Team have also included a video on our website called “how to make an application” to further assist homeowners in the application process. In addition, CCC’s DCB team is available to assist with any queries homeowners may have. Clare County Council continue to administer and validate applications since the commencement of the scheme via the online portal. Clare County Council are engaging with the Housing Agency and the DHLGH and continue to carry out all associated duties.

To date, Clare County Council have issued 37 Remedial Option Grants, with the total value of €11.45m awarded by the housing agency and are awaiting input from the Housing Agency to further process 86 applications with grant amounts to follow.

## SOCIAL DEVELOPMENT

CCC intend to hold further information evenings in 2025 to target people with limited digital resources and/or capabilities, to assist them further in making an application and other elements of the DCB application process.

Clare County Council continue to engage with the DHLGH to ensure social houses affected by DCB are included in a similar scheme.

### Update on capital programme:

The Doonbeg and Gort Road projects are under construction and these projects continue to progress well. Other housing capital schemes are progressing well and are at varying stages of design and construction across the County Clare. The construction contract was signed for the Shallee Drive/ Cloughleigh Road housing development and this will commence prior to end of Q1 2025.

## UKRAINIAN SERVICES TEAM

The CSO figures show there were 692 Temporary Protections granted nationally in the past month with an average of 25 granted per day, the number of new arrivals into the Country has increased by 80 people compared to the weekly figures outlined in the previous Monthly Management Report. There are currently 5,080 Ukrainian Beneficiaries of Temporary Protection (BOTP's) living in County Clare, representing a decrease of 37 people in the County compared to figures released previously. There are 1,350 people accommodated in 25 multi-occupancy facilities located throughout the County - this reflects a decrease of 95 people compared to previous figures. The remaining people are accommodated in residential settings in formal hosted arrangements through the Irish Red Cross and Clare County Council's Offer-a-Home scheme. There is still huge interest in the scheme since it's launch in November 2022, we currently have 259 homes offered resulting in

an increase of 2 properties compared to figures released previously. We currently have 3 new properties offered that will be available during the month of March. To date our Matching & Relationship Manager has facilitated the accommodation of 518 people that were originally living in hotel and multi-occupancy facilities.

The Government has confirmed the Temporary Protection status for Ukrainian people fleeing the war which was due to expire on 4th March 2025 has now been extended for another year. Applications to renew the temporary protection status up to March 2026 must be submitted to the Irish Immigrations Office.

The Government will have a decision on the future of the Accommodation Recognition Payment Scheme (ARP) in the coming weeks, the current ARP arrangement will expire at the end of March 2025.

## LOCAL AUTHORITY INTEGRATION TEAM

The Local Authority Integration Teams (LAITs) have been set up in all local authorities. Their purpose is to help coordinate the different kinds of support available for people who are applying for international protection, refugees, and others in similar situations.

The goal of LAITs is to help IP applicants and refugees become independent, settle into their new communities, and participate in Irish life. They do this by connecting people to important

services that can help them integrate into the community.

### Who do LAITs support?

LAITs provide support for:

- Applicants for International Protection (IP)
- People who have been granted refugee status or other forms of protection, such as subsidiary protection or permission to remain

- Refugees who have been resettled in Ireland through a government programme
- Beneficiaries of Temporary Protection (BOTPs)

### How is the support provided?

LAITs operate under the principle of 'Integration from Day One'. This means that LAITs provide integration support to people who need it as soon as they arrive in Ireland.

What services do LAITs provide?

The work of LAITs isn't meant to replace existing services. Instead, LAITs help connect people with the existing services that are most suitable for their needs. This includes things like:

- Being a direct contact for new arrivals, helping them with any problems they might have when dealing with public services
- Connecting new arrivals with services like legal help, childcare and healthcare
- Connecting new arrivals with services that improve their ability to live independently, like job training, English classes, education, and apprenticeships
- Guiding new arrivals through the process of applying for financial support, medical help, child benefits, and other services they might need
- Holding meetings in local areas and using community development principles to help those who attend
- Supporting people if they face racism or other unfair treatment, helping them report it to the right authorities
- Helping vulnerable new arrivals get in touch with non-governmental organisations (NGOs) and other services if they need extra help

As a follow-on to this seminar, Shannon Chamber, in collaboration with the Department of Social Protection and the Local Authority Implementation Team (LAIT), will host a Jobs Fair in Shannon on Wednesday, 26 March 2025 from 10am until 1pm as part of the Department's annual Work and Skills Campaign. While the venue has yet to be announced, employers with open vacancies in their companies are invited to send a list of such positions to Shannon Chamber and have a representative(s) at the Jobs Fair to engage with prospective candidates.

## ESF+ Sport4Empowerment Programme

### General update on your operational plan:

#### • Swim Ireland Pilot:

- The initial lessons for 7 male members of the travelling community have been completed, showcasing mixed abilities within the group.
- An additional 4 lessons are required to bring 2 participants up to an equal standard.
- Suitable pool time for the group is still being arranged.

#### • Lisdoonvarna Pilot Project:

- This project, targeting Ukrainian refugees in collaboration with Weightlifting Ireland, is set to expand.
- Currently, the project includes a group of cancer survivors who formed a Dragon Boat club with assistance from the Clare Sports Partnership.
- The new phase will commence on 12th February.

#### • Couch to 1Km:

- Launched on 21st January for the Housing First Group.

#### • Fabio's Work Experience:

- Fabio has started his work experience with Clare Sports Partnership.
- The goal is to empower him to co-design a programme specifically for the Roma community.
- After conducting focus groups with Roma youth, two programs have been designed: "Namaste Yoga Ennis" for teen girls and "Strength and Fitness" for boys (in collaboration with Spartan Fitness).
- These programs are set to commence in late January, following the Roma community's return from Slovakia/ Czech Republic after the Christmas period.

#### • GAA Adult Introduction for International Protection Applicants:

- Further liaising with GAA Games to develop an introduction to GAA aimed at International Protection Applicants.
- The ultimate aim is to create a football team comprised of 'New Communities,' with an exhibition game in Cusack Park.
- Coordination with CLDC and CISC on outreach efforts to gauge interest and find a suitable location to host.

#### • Cúl Camp for IPA Children:

- GAA has approached us to run a Cúl Camp over Easter for IPA children, sponsored by Kelloggs.
- Coordination of 3 other camps via ESF officers in other counties for the same cohort.
- Meetings with Hartnell Wilson – Social Impact

Communications for GAA/Kelloggs are ongoing to finalise details.

- One camp will take place in Lisdoonvarna during Easter.
- **Research Funding:**
- Collaboration with Clare Haven on the 'Participatory levels of Children from Domestic Violent Households in Team Sports' project.
- The project is being proposed to their board, with ethical concerns under consideration.

#### • Walkability Audits:

- Liaising with Clare Traveller CSP to conduct 'walkability audits' from Traveller-specific accommodation using National Roads Authority templates.
- Four audits have been completed.

#### • Formal Referral System:

- A formal referral system to the ESF+ role from SICAP, Local Area Employment Service, Employability, Traveller CPD, Focus Ireland, and Probation Service has been initiated.
- This system is for individuals seeking training, interested in training, or needing support to get active in sports again.
- Twelve clients have been referred and met so far.
- The referral system will expand to include the Links Worker client base and internal referrals.

## Green Team – EarthCheck Audit



Achieving the vision as set out in the Clare Tourism Strategy 2030 which is that 'Clare is a globally renowned sustainable and vibrant destination' requires all tourism interests in Clare, supported by government and national agencies to work together to deliver an outcome that enriches all communities across our County.

Many steps have been taken to achieve this objective and the key milestone took place on the week the 19th February 2025, when EarthCheck conducted a week long audit on the Tourism infrastructure of Clare. This audit sets Clare to become an internationally recognised and certified destination to GSTC (Global Sustainable Tourism Council) standard.

The auditor met with the Interim CE and Director of Service for Tourism Development and subsequently met with the established Green Team. The auditor reviewed the work conducted by the Green Team to date, which continues to enable Clare to measure and monitor the impact of Tourism.

The areas of audit also included the work practices across all relevant directorates in the Council (Environment, Recycling plants, Climate Action, Roads) and Uisce Eireann (Water and Wastewater) as well as the Cliffs of Moher Experience, Vandeleur Walled Gardens and Visitor Centre in addition to Shannon Airport Group and ESB Moneypoint.

The formal outcome of this EarthCheck audit will be announced in due course.



## Launch of the Cliffs Coast Destination Experience Development Plan (DEDP)

Fáilte Ireland launched a new five-year plan to help drive and sustain tourism in North Kerry and West Clare (Cliff Coast).

The Cliff Coast Destination and Experience Development Plan (DEDP), launched at Ballygarry Estate Hotel and Spa, Tralee, aims to create a sustainable tourism destination by extending the tourism season and spreading business across all parts of the region over the next five years.

Key stakeholders in the area were consulted and contributed to the plan including Clare County Council, Kerry County Council, Irish Hotels Federation, LEADER, local tourism groups and local tourism operators and networks.

The Geopark geologist Dr. Eamon Doyle was pleased to provide geology training for NPWS guides from the Burren National Park and Coole Park. This geology training is an important part of the guides overall knowledge of the Burren National Park.

## Broadband & Digital

### Economic, Social and Community Impact Assessment for Ennistymon Digital Hub



In order to determine the overall impact of the Ennistymon Digital Hub and Multi Service centre on the town of Ennistymon and its environs, the Digital & Broadband Department commissioned an Economic, Social and Community Impact Assessment for Ennistymon Digital Hub.

The Ennistymon Digital Hub, part of Clare County Council's "Digiclare" initiative, aims at supporting rural communities by offering flexible, affordable office spaces. The Hub, opened in December 2019, serves as a community and enterprise hub, providing hot desks, office space, and meeting rooms. Due to

increasing demand, it expanded in 2022, adding more office pods and desks.

These are the main findings:

#### Key Impacts

##### 1. Social & Community Benefits

- Supports remote work for both local residents and visitors.
- Enhances work-life balance by reducing commuting times.
- Encourages tourism and economic activity in North Clare (notably benefiting businesses in Lahinch).
- Contributes to town rejuvenation, especially on Parliament Street.

##### 2. Economic Impact

- 76 Full-Time Equivalent (FTE) jobs created (direct & indirect).
- Annual economic impact of €3.8 million.
- Generates €586K in tax revenue.
- 67% of relocated workers identified the Hub as a key factor in their move.
- Encourages local spending—89% of users shop locally more frequently.

**3. Tourism & Remote Work ("Workcation")**

- 60% of summer bookings (Aug 2024 sample) came from tourists & holiday-makers.
- Strengthens Ennistymon's appeal as a remote working destination.


**4. Sustainability & Policy Alignment**

- Reduces carbon footprint by cutting commuting.
- Supports several UN Sustainable Development Goals (SDGs), including good health, economic growth, and climate action.

- Aligns with local and national policies promoting digital hubs and sustainable work solutions.

### Storm Éowyn:

While Storm Éowyn many have hit in January the fallout and clean up of this extremely powerful extratropical cyclone continued well into February following the record breaking windspeeds which were recorded in some parts of Ireland during Storm Éowyn.

Large scale disruption was caused to electricity supply, water supply and telecommunications systems in West Clare. The West Clare MD crews were to the forefront in clean-up operations after Éowyn.

**Schedule of Municipal District Works 2025:**

In the last month the West Clare MD has continued to carry out drainage works and road surface preparation works prior to the commencement of the 2025 Schedule of MD works.



**Housing Development Road Surfacing:**

A section of the deficient road surface in Mountshannon Estate, Labasheeda was removed by planing and a new DBM surface laid. The road surface in the Clare County Council developed housing estate had reached the end of its useful life. The overlay was funded from Planning Development contributions.



**Hedgerow Contractors Training:**

Staff from the MD, external hedgerow contractors and elected members attended a training workshop in Bunratty provided by Clare County Council and Limerick County Council's Biodiversity Officers.

Appropriate Hedgerow Maintenance and Invasive Species management are ongoing issues for Council's across the country and this is becoming a more important issue with the introduction of a new Protection of Hedgerows Bill and the EU Nature Restoration Law.

This training event informed on best practice around hedgerow cutting for future hedgerow maintenance.

Clare County Council presented their Tree Survey solution at the Good Practice in Local Government conference held in Kilkenny castle on the 13th February, organised by the National Oversight and Audit Commission (NOAC) in collaboration with the County and City Management Association (CCMA) and the Local Government Management Agency (LGMA).

The Tree survey project enhances tree management in urban areas, promoting a greener and safer environment for all. The digital Tree survey solution, funded by the Heritage Council in 2023, was developed inhouse and offers numerous benefits:

- Detailed maintenance records for specific trees and locations
- Assistance in preparing tenders
- Reduced risk of damage from trees during storms
- Justification for tree removal

- Consistency of maintenance records
- Mitigation against claims
- A digital dashboard for better decision-making and efficiency

This project is part of Clare County Council's broader innovation strategy, which includes various initiatives such as PRTB housing inspections, lifeguard reporting services, and traffic management for road worker safety. These efforts led to Clare County Council winning the CIPD awards for "Embracing New Ways of Working" and "Rising IT Star" in public sector digital transformation in 2024.

The Tree solution generated significant interest from other authorities eager to adopt it. The digital strategy team at the LGMA will assist other authorities adopt the solution through the Build to Share initiative.

#### THRIVE Ennis - Town Centre First Heritage Revival Scheme



A Part VIII Planning application was lodged by Clare County Council in December which will bring forward designs to regenerate/adapt The Cloister, a significant heritage building and national monument in Ennis, which will be brought back into use while addressing community needs.



The Council expects to apply for Thrive Stream 2 funding in April 2025 to bring this project to fruition. THRIVE is funded by the government under the ERDF Regional Programmes through the Southern Regional Assembly.

A draft Integrated Urban Strategy focussed on heritage is in preparation and stakeholder engagement sessions are due to be held on 11th March 2025 in the Foyer of Áras Contae an Chláir. The Strategy will be a good opportunity to highlight potential heritage buildings that should feature in the Strategy and could benefit from future Thrive funding streams.

## FORWARD PLANNING

#### Kilrush Maritime Training Centre

Work is continuing on the Kilrush Maritime Training Centre Project to identify a suitable funding stream to cover the remaining funding gap within the project. The Project Team are liaising with the Department of Rural Regeneration and Community Development with respect to due diligence on the projects funding allocation. In addition, Enterprise Ireland are concluding their analysis of the Smart Regions funding scheme to establish if the Kilrush Maritime Training Centre project can apply to this scheme to cover the remaining funding gap.



#### Strategic Integrated Framework Plan (SIFP) for the Shannon Estuary

Following a successful Request for Quotation process Clare County Council acting as Lead Authority on the SIFP Steering Group and Environmental Sub-Group have appointed Quiet Oceans to prepare and deliver the first ever anthropogenic background noise map for the Shannon Estuary. The appointment was approved by the SIFP

at the recent Steering Group meeting held on the 20th of February in Clare County Council. The Planning Department will act as the key point of contact for the project on behalf of the members and will provide access to data where available to facilitate the commencement of the study.


**Marine Planning**

The inaugural Energising Clare conference took place at the Temple Gate Hotel in Ennis on Friday the 14th of February. The event was organised by Ennis Chamber in conjunction with Wind Energy Ireland. It was revealed that Clare produced the 7th highest amount of wind energy in the country last year, accounting for 4% of Ireland's total. Wind Energy Ireland CEO, Noel Cunliffe, and Minister with Special Responsibility for Fisheries and Marine Protection, Timmy Dooley spoke of the challenges facing wind energy production in County Clare both in terms of onshore and the future potential challenges of offshore floating wind production. Interim CEO Carmel Kirby highlighted the urgency in terms of the preparation of a West Coast DMAP and the importance this sector plays to the region. The Government Plan Led approach is needed to inform the future development locations of these potential floating offshore wind farms.

Wind Energy Ireland CEO Noel Cunliffe highlighted delays in decision making within An Bord Pleanála as a concern in reaching our climate action targets. His planning dashboard provided an oversight of the targets achieved in 2024.



**Residential Zoned Land Tax (RZLT)**

The Residential Zoned Land Tax (RZLT) final map for 2025 and the annual draft map for 2026 are now on public display. **Submissions regarding both maps can be made until 1 April 2025.** For the Final Map 2025, landowners may request the local authority to change the zoning status of their land, included on the map. For the Annual Draft Map 2026, both landowners and members of the public may make submissions regarding the inclusion or exclusion of lands. Details on how to make a submission and links to both maps are available on the Council's website via the planning section. Hard copies of both maps are also available to view at the Council offices

and libraries around the county.

The Residential Zoned Land Tax came into effect on 1 February. The purpose of the RZLT is to activate land that is zoned and serviced for residential or mixed use land to increase housing supply and to ensure the regeneration of vacant and idle lands in urban locations. Local authorities are responsible for the preparation of mapping and identifying lands considered 'in scope' and the Revenue Commissioners are responsible for the collection of the tax. RZLT is an annual tax charged at 3% of the market value of 'in scope' lands. The Final RZLT Map for 2025, published on 31 January 2025 shows 'in scope' lands subject to the tax. Payment of the RZLT to

the Revenue Commissioners is due on 23 May 2025.

## HERITAGE

### Clare Heritage Plan application to the Heritage Council.

The Heritage Officer has applied to the Heritage Council for co-funding for the following projects:

1. To continue with the Clare Community Archaeological Scheme
2. Projects to be undertaken in 2025 subject to funding are as follows:
  - a) The deconstruction and reconstruction of a partial mud house in Tullaroe, in partnership with the West Clare Municipal District and the Querrin local community. This work is needed to widen the road at the site of this house ruin.
  - b) Analysis and community consultation of the remote sensing carried out in Loop Head in 2024
  - c) Making additional Heritage information accessible and available to the public by providing a Partner Website on the Clare County Council main website via Clare iCAN website.
  - d) Continue with the TY Tasters Traditional Skills training with secondary school students and the formation of a

Traditional Skills directory or register for the county.

- e) Support and participate in the Killaloe-Ballina History Society and Burrenbeo Trust Archaeological conferences. And the Group for the Study of Irish Historic Settlement who will hold their annual conference in Killaloe in May of this year.

### Clare Creative Ireland funding for Heritage

Clare Creative Ireland funding has been secured from two heritage projects as follows:

- (a) Undertaking a *Reading Your Local Landscape* course in West Clare in association with the Limerick Clare Education & Training Board in September. The course will be advertised shortly.
- (b) Finalise the Clare Cillíní Survey and upload the survey information onto the Clare Heritage iCAN website. The Cillíní survey will be launched for public awareness, engagement and to promote access to the site survey information. Cillíní events will be held with interested communities to inform, engage and to commemorate the more than 144 Cillíní sites around the county and their significance.

The Clare Creative Ireland team held a meeting to discuss and input into the Evaluation Framework for the Creative Ireland Programme 2023-2027 developed by the Department of Tourism, Culture, Arts, Gaeltacht, Sports and the Media (DTCAGSM). This evaluation frame work includes a review of the outputs and outcomes of Clare Creative Communities. The outcomes of this evaluation may impact on decisions around future investment for the Creative Ireland programme.


### Clare Heritage Website, iCAN

Clare County Council have agreed a partnership agreement with the National Museum of Ireland (NMI) regarding the delivery of the Clare iCAN programme 2023 -2028.

Clare County Council has worked with the National Museum of Ireland NMI on the iCAN programme since 2019. There are presently 6 Clare Communities up and running on the iCAN network, each with a professionally designed website within the portal. There is interest from other Clare communities in joining the Clare iCAN network.

In 2025, the Clare iCAN groups will be offered training, will undertake projects and receive funding under this agreement. Several network meetings are planned throughout the year, where the Clare groups come together on a local and national basis to learn from each other, undertake joint awareness, local history and archival projects.

In 2025, Clarecastle will receive funding for QR-coded plaques for the local Heritage Trail, Dúchas na Sionna are supported to produce a promotional brochure and video, Ruan/Dysart will receive funding to purchase equipment, and the Scattery Island group are funded for their postcard project.

### Lisdoonvarna Historic Town Initiative HTI

As part of the Historic Town Initiative for Lisdoonvarna Spa Wells, a Conservation Management Plan (including Gazette of the Existing Rooms, an outline of Essential Works and a 10-year Management Plan), Heritage Led-Regeneration Plan (including Architectural Drawings, Ecological Appraisal and high-level preliminary Budget Estimates), a detailed Business Case and a Topographical Survey was produced.

The Business Case examined the Heritage Led-Regeneration Plan in the context of wellness tourism and made a proposal for regenerating the Spa Wells experience. A Tourism Impact Assessment and business case rationale was undertaken. The outcomes of this work was presented to the West Clare Councillors by the consultants involved, Myco Studio and Rubucon.

### Community Monument Fund (CMF)

There was a lot of interest from community groups and church organisations in the Community Monument Fund (CMF). Site visits were made to a wide variety of monument types and advice given on the CMF application process. Nine applications were forwarded by Clare County Council to the Department of Housing, Local Government and Heritage in February for their assessment. Two applications were made by Clare County Councils on their own properties. The Heritage Officer in partnership with the Special Projects Team has sought funding for the provision of a small car park at Beal Ború fort in Killaloe under the scheme.

### Heritage of West Clare and the Green Team

The Heritage Officer made a presentation on some Heritage projects in West Clare to communities and businesses in Loop Head, as part of the County Clare Destination Green Team on the journey toward securing Ireland's first certified sustainable destination.

The Heritage Officer provided advice on the Heritage Council works taking place at Dromore Stables to safeguard one of the most important colonies of the rare and endangered Lesser Horseshoe Bat in Ireland.

### Current Heritage Funding and Project Opportunities

#### a) Community Heritage Grant Scheme 2025

The Heritage Council's Community Heritage Grant Scheme 2025 is open for community and voluntary groups, and NGOs and stays open until 14th of March.

The Scheme is open to:

- Voluntary and community groups, for example, parish councils, tidy towns groups, local action groups etc.
- Non-governmental organisations (NGOs) including not for profit trusts.

The Scheme funds a wide range of heritage projects. In 2024, ten projects in County Clare were supported, received funding from €800 to €25,000, on average the funding available is €10,000 to €15,000. The scheme funded the Cuimhneamh an Chláir / Clare Memories group to archive their oral histories with the Digital

Repository of Ireland, the Old Ennistymon Heritage Company were funded to undertake repair works to the Ennistymon Courthouse building using traditional lime mortar techniques, while the X-PO Kilnaboy were funded to make a lovely film on the traditional method of cutting reed for thatching on the wetlands of the Shannon Estuary which has been shown at the X-OP in Kilnaboy and the County Library.

### Traditional Farm Buildings Grant Scheme

Traditional Farm Buildings Grant Scheme with the Department of Agriculture, Food and the Marine is now OPEN for applications. The closing date for receipt of completed applications is **5pm Monday 10th March 2025**.

In 2025, the Heritage Council particularly encourage applications for the repair of traditional farming structures other than buildings. To support this effort, it is intended that €500,000 be specifically allocated this year for the repair of these other related farm structures such as walls, gate pillars and gates, walled orchards, cobbled yards and masonry dung steds.

### Adopt a Monument Scheme

"The Adopt a Monument Scheme" aims to ensure that our monuments remain an integral part of the community. The scheme provides expertise and resources on the maintenance and care of the chosen Monument. The aim is that the monument will serve as a focal point for heritage-related, educational and recreational activities and will encourage greater appreciation and understanding of local heritage. With funding from the Heritage Council "The Adopt a Monument Scheme", the Labasheeda Projects Group commissioned ecological and architectural surveys and developed a walking trail to the site.

### Hedgerow Training Workshop at Bunratty Castle and Folk Park

On the 13th of February, Clare County Council's Biodiversity Officer and Limerick City and County Council's Biodiversity Officer teamed up at Bunratty, Co. Clare to organise a workshop for external hedgerow contractors and council staff (Clare and Limerick) on the sustainable management of hedgerows for biodiversity and best

practices in relation to invasive species. The workshop promoted to adopt the 'A-shape' profile of hedgerows and light trimming to benefit bats, birds and mammals. The workshop involved an outdoor site demonstration on the sustainable management of hedgerows to transition away from the traditional 'box cut' hedgerow and to adopt an 'A-shape' (triangular shape) by cutting the hedgerow at an angle at the highest point to allow the hedgerow to grow upwards and give the hedgerow height to function as an ecological corridor for wildlife. Clare County Council's Biodiversity Officer Barry O'Loughlin gave a presentation which covered best practices in relation to hedgerow cutting and management, legislation and ecological corridors. The Limerick Biodiversity Officer Sinead McDonnell covered the benefits of grass verges and hedgerows for biodiversity. Will Earle of INVAS Biosecurity covered best practices and biosecurity in relation to invasive species while Catherine Keena of Teagasc spoke about tree management of hedgerows and best practices in relation to hedgerow rejuvenation. This workshop was timed in advance of the bird nesting season to highlight ecological sensitivities. A special thank you to all speakers, MD Staff, Elected Members of the Council and hedgerow contractors that made the event. Thank you also to the staff at Bunratty Castle and Folk Park for all their help and assistance. This training event was funded by the Local Biodiversity Action Fund (NPWS), Clare County Council and Limerick County Council. The Biodiversity Officer Programme is funded by the Heritage Council in partnership with the relevant local authorities.

**Tourism SPC Meeting: Biodiversity Work Programme and Visitor Destination Sites**

On the 19th of February, Clare County Council's Biodiversity Officer gave a presentation to the Tourism SPC Meeting on the Biodiversity Work Programme and biodiversity initiatives undertaken at visitor destination sites within the Council's landbank. The Biodiversity Officer has worked closely with operations and gardening staff in Vandeleur Gardens in Kilrush and Loop Head Lighthouse to adopt pollinator friendly mowing regimes on the grounds. This involves delaying the mowing regime to allow wildflowers to grow to provide a nectar and pollen source. The Biodiversity Officer has also met with staff at the Cliffs of Moher Visitor Centre to advise on mowing regimes to link in with the All-Ireland Pollinator Plan. The pollinator actions were reported in the All-Ireland Pollinator Plan Council Annual Report. The Biodiversity Officer has funded through the biodiversity budget a Biodiversity Conservation Management Plan for Craggaunowen near Kilmurry, Co. Clare in addition to profiling some visitor destination sites to promote the conservation of wetlands through the Clare Wetland Story Map.

### World Wetlands Day Event: Launch of Clare Wetland Initiatives

Clare County Council’s Biodiversity Office launched the Clare Wetland Story Map and the new wetland guidelines aimed at community groups and landowners ‘Community Action: A Beginner’s Guide to Wetlands’ on the 4th of February at the Civic Room, Buttermarket Building, Ennis. Clare County Council’s Biodiversity Officer Barry O’Loughlin discussed how communities can integrate local wetlands into their Community Biodiversity Action Plans and promote wetlands through talks and walks. Poppy Overy of Wetland Surveys Ireland provided an overview of the Clare Wetland Field Survey 2024 and the benefits of mapping wetlands in Clare. Patrick Crushell of Wetland Surveys Ireland gave a demonstration of the new online digital interactive Clare Wetland Story Map and how communities and schools can use this as an educational resource and the simple measures communities can do to protect wetlands. Laurence Fullam of the Community Wetlands Forum spoke about successful peatland restoration initiatives including Shanakyle Bog in Co. Clare and discussed how the new ‘Community Action: A Beginner’s Guide to Wetlands’ booklet can be used by community groups to embark on a new wetland project. Landowner Feargal Marren spoke about the Marsh Fritillary Conservation Project he is embarking with the local community in Clonlara. This project is funded by Clare County Council’s Biodiversity Office and NPWS. The projects are funded by Clare County Council, NPWS and Creative Communities Funding (through Clare Libraries). The advertisement for the annual grazing of Council owned lands was published in January with a closing date of 27th January, 2025. During the month of February, the grazing agreements have been signed up for an eleven month period.

**PROPERTY MANAGEMENT**

**Property Transactions and Conveyancing**

The Table below shows the number of property transactions completed by Property Management Unit up to 19th February 2025 and the corresponding figures for 2024.

The property market in the County continues to be quite active, albeit that there is a shortage of supply, particularly in the residential sector. The Property Management unit continues to assist many solicitors acting for their clients on issues associated with title, boundaries, old leasehold folios etc. We are also processing a number of applications for first registration of Council property and assessing the various properties we own for correct title.

**DERELICT SITES**

The Derelict sites team are currently dealing with 278 properties that are considered derelict. We continue to have high levels of activity and engagement with owners and their representatives. Initial engagement with owners or their representatives is key to resolution of the issues of dereliction and to gain an understanding of the various reasons why the properties are in a derelict state. Where derelict properties are sold by the owner, we commence engagement with the new owners of those properties to ensure they are aware of their responsibilities under the Derelict Sites Act, 1990.

We are also seeing a consistent number of planning applications for property refurbishment/extension and it is clear from driving around the county the level of work ongoing on individual properties. We are advising property owners of the vacant property refurbishment grant if the property is suitable for residential use. With time and effort, working with owners, financial institutions and other departments, there are definite options for positive re-development and revitalisation of many such derelict sites.

The table below provides a snapshot of the activity in February 2025 and year 2025 to date and the comparative figures for the full year 2024.

### Compulsory Acquisition of Derelict Sites (CPO)

The Department of Housing, Heritage and Local Government launched a CPO activation programme in 2023 for local authorities, which set targets for CPOs for each local authority. The Table below sets out the status of CPOs commenced by the Derelict Sites Team in Clare County Council since 2022 to the current year. It is important to note that the CPO process can be lengthy and complex.

In addition, the Urban Regeneration and Development Fund will provide funding for CPOs on a rolling basis in the town of Ennis with the objective being that these properties would then be sold on the open market. A particular emphasis will be on properties that have potential for residential use. Two such CPOs are with the PRA for registration. Actions taken on properties in the town of Ennis has resulted in a number of properties coming to market or making plans for site development.

### Derelict Site Levy

Determination of valuations on sites which are on the Derelict Sites Register commenced in 2023 and notices of valuation have issued to 26 properties to date. Three owners appealed the valuation to the Valuation Tribunal and while decisions are awaited on two appeals, one appeal by an owner was rejected. The levy is an annual levy while the property remains on the Derelict Sites Register and amounts to 7% of the value of the property, on an annual basis. Assessment of valuations and billing of the levy will be further progressed during 2025 and it is intended that all properties on the Derelict Sites Register will be valued for the purposes of billing the levy. This levy will go towards the cost of billing and collection of the levy and resourcing of derelict sites function, up to and including CPO of properties.

The Table below shows the levels of activity on the Derelict sites levy as of 19th February 2025. Further properties on the Derelict sites register are being valued for the purposes of the Derelict sites levy on a regular basis.

## VACANT PROPERTY REFURBISHMENT GRANT - FOR DERELICT AND VACANT PROPERTIES

The Council welcomes the inclusion in the draft programme for Government of the intention to extend the Vacant Property Refurbishment Grant to 2030. A meeting has been arranged with officials in the Department for April to establish if there are changes proposed to the scheme and to update them on the work ongoing in County Clare.

To date the value of grants approved under the Vacant Property Refurbishment Grant by Clare County Council has exceeded €20 million as at 19th February 2025 (338 grant applications approved or 65% of all applications), with further approvals due to issue. This is a very significant investment in housing in County Clare and the work ongoing around the county on renovations and extensions is very visible. The Vacant Homes Team continues to advise applicants on all elements of the scheme and is available to meet with individuals to take them through the process.

The Grant is making a real difference in boosting the supply of rental properties and properties for permanent residence and will deliver on a key priority of 'Housing for All' National Policy and the Vacant Homes Action Plan, the key objective of which is to reduce vacancy and dereliction in our cities, towns, villages and rural countryside and provide more housing options in the process.

A number of walk-in advice clinics will be held in 2025 where property owners can come in to meet the Vacant Homes Team for advice regarding making their applications. Any applicant can meet with the Vacant Homes Team in Áras Contae an Chláir by appointment or can discuss their application over the phone with any team member.

We continue to have high levels of enquiries and applications for the Croí Cónaithe Vacant Property Refurbishment Grant and the total applications since the scheme was introduced in July 2022 is

now 517. We are in the top eight local authorities in the Country in relation to application numbers. Our response time for initial assessment of new applications is generally four to five weeks.

At mid February, we have paid out €4.7 million to 83 property owners in County Clare who have completed works and many others are in the process of submitting their claims for payment. The final site inspections are organised and the administration of the financial and legal elements of the grant are completed. The level of claims for payment is increasing every day and the Team work closely with owners on this process.

### Local Authority Purchase and Renovation Loan.

A new loan has been launched by Government called the Local Authority Purchase and Renovation Loan. It is a government-backed mortgage and loan that helps people to buy and renovate a derelict or uninhabitable home. The loan is for first-time buyers, and 'fresh start applicants', who have been unable to get funding from commercial lenders. It is an extension of the [Local Authority Home Loan](#). The applicant must qualify for the [Vacant Property Refurbishment Grant](#) to get this loan. The Housing Department will administer this loan and work closely with the Vacant Homes Team.

### Other Points of Information

- Changes to the grant were announced in late 2024 to be in line with the Energy Performance of Buildings Directive (EU/2024/1275). In order to meet the timeline in Article 17(15), the Vacant Property Refurbishment Grant will no longer fund the installation of stand-alone boilers powered by fossil fuels, for new applications from 1st December 2024. This is being notified to all new applicants
- The breakdown of applications between urban and rural areas has remained consistent - 56% of applications are for rural areas of the county and 44% for properties in towns and villages.
- To date, 71% of applications are for properties to be used as principal private residence (333 properties) and the balance of 29% are for rent. This has remained consistent in recent months.
- A number of property owners have applied to have the period to complete the works extended. Such requests are considered on a case by case basis, depending on the level of work carried out to date and the timeframe needed to complete the works.

## ENNIS MUNICIPAL DISTRICT

February was another busy month for the MD Staff with a number of significant works being progressed as well as the ongoing operation and maintenance of key infrastructure in our charge.

Some of the key works progressed throughout the MD area in the past month include the following:

### Clarecastle Works

In February Ennis MD installed new footpaths and junction improvements in Clarecastle Village between the community centre and the centra shop. This project has come to fruition through strong representation from the public and elected members. The works were carried out under Section 38 of the Road Traffic Act.

The scheme involved the installation of the following:

- new footpaths,
- raised concrete hammerhead junction,
- an uncontrolled pedestrian crossing,
- new parking layouts and signage installation.

The works were carried out by Cotter Plant Hire for the Ennis Municipal District office and the works were completed over an accelerated programme of three weeks in order to minimize disruption to the adjacent shop. The project also ensures users and visitors of the Clarecastle Daycare Centre have safe pedestrian access to the village.



### Road Maintenance

Ennis MD crews have been busy during February carrying out the annual winter road maintenance work throughout the Ennis area.

This work involved:

- cleaning gullies
- trimming road edges
- litter picking
- sign cleaning
- filling potholes



### Storm Éowyn

The clean up after the destruction of Storm Éowyn continued for the first three weeks of February. Crews were busy collecting and mulching branches, removing trees that were uprooted or displaced, reinstating sections of roads that were damaged by the roots of fallen trees and cleaning up works and forestry walks of any fallen trees and overhanging branches.



### Valentine's Day


Valentine's Day graphics was projected at O'Connell Square with the O'Connell Monument light in red from our programmable LED lighting installation.



### Ennis URBACT eConnecting Project.

Town Engineer Donnagh Murphy and our colleague John Treacy from the Rural Development Directorate travelled to Tori, Estonia in February as part of the Ennis URBACT eConnecting project that we are the Irish partner in. Network partners that attended the event included representatives from Italy, Slovenia, Hungary, Greece, Portugal, Estonia and Montenegro.

One of the main focuses of the project over the coming months will be to develop an integration action plan for Ennis, which will address and identify strategic objectives associated with urban-rural mobility, environmental sustainability, regional development and community led solutions. The plan is due to be completed in Q3 in 2025, an added outcome of which will be that it will assist greatly in applying for future funding streams.



### Other Key Strategic works

In addition to the aforementioned, Ennis MD staff continue to work on a number of other key projects such as the Area Based Transport Assessment (ABTA), the Town Bus Project and also, on a cross-directorate basis with our colleagues and the various Government Departments in advancing a number of other works throughout the Town and Environs. These include the Ennis Public Realm Project, the LIHAF Access Road project, the THRIVE project at the Cloister and the Tulla Road and Clare Road Active Travel Projects.

We also work closely with our DAC colleagues in developing the ambitious plans outlined in the Ennis 2040 Economic & Spatial Strategy. Another key development in the Town soon to commence works will be the Carpark project on GAA lands between the Garda Station and Cusack Park. Once completed, this will provide approximately 200 car spaces in the town centre location which will be very welcome news indeed.

This will ensure that pedestrian connectivity is in place along this well-trafficked route in time for the 2025 tourist season. Staff are available to meet and brief the local Elected Member as required.</p>
<b>Ennis Public Realm Regeneration (Project B)</b>	<p>The appointed contractor Shareridge Ltd. is progressing works at number of locations. Civils and construction crews are now deployed throughout the town centre, in accordance with Phasing plan. An extensive area has been opened up at the Cathedral, and already paving is being finished out, in combination with preparations for street trees and planters. A section has been prioritised for paving so as to restore pedestrian routing from Station Road to O'Connell Street ahead of phase completion. This has greatly improved access in the area and eliminated the need for diversions through the Cathedral grounds.</p> <p>The intensive works programme continues along sections of upper O'Connell Street and the contractor has recently mobilised to O'Connell Square. Completion crews have also been dedicated to works on High Street, and for snagging on uncompleted sections of O'Connell Street.</p> <p>In coming weeks, the contractor will be deploying dedicated works crew to the O'Connell Street/Market Street junction, for which works will be largely scheduled on evenings in order to minimise impact on traders. In such areas of narrow street width, activity will be completed Out of Hours to facilitate pedestrian movement through these street sections.</p> <p>Consultation with impacted traders and stakeholders is ongoing, and the contractor has appointed a Public Liaison Officer in this regard, in line with Works Requirements. A focused Stakeholder Consultation event was held on 9th December 2024 to review the updated phasing plan and inform stakeholders as to upcoming works phases. 

### Training Courses

Clare County Fire & Rescue Service personnel underwent a number of training courses during February, including Bronto Aerial Appliance Operator Initial & Refresher training held in Ennis Fire Station and Compartment Fire Behaviour Training (CFBT) held in Hackettstown, Carlow.

### Storm Éowyn - Fire Service Response

Storm Éowyn was an exceptionally powerful and record-breaking extratropical cyclone that struck Ireland in the early hours of Friday, January 24, 2025. Named by the UK Met Office on January 21, the storm prompted widespread red weather warnings across the country as it rapidly intensified. It was the strongest and most severe storm to hit Ireland since Hurricane Debbie in 1961, breaking an 80-year-old national wind record. The highest recorded wind gust in Ireland reached 183 km/h (114 mph) at Mace Head, with devastating effects, while a maximum wave height of 10.4 meters (34 feet) was measured near Doolin, County Clare.

By 09:00 on January 24, approximately 815,000 homes, farms, and businesses across Ireland were without power, including around 44,400 customers in County Clare amounting to 74% of

the county's ESB customers leading to widespread water outages and loss of telecommunications. As conditions improved, Clare County Fire & Rescue Crews initially responded to 127 emergency incidents and later when conditions allowed were joined by Clare County Council crews clearing transportation routes of fallen trees and other obstructions. Their huge efforts to restore access, assess storm damage and support recovery would continue for several days and into the following week.

Throughout the following week into early February, the council's Crisis Management Team and the Interagency Local Co Ordination Group for County Clare continued to meet and to co-ordinate the response to the restoration of power, facilities, transportation routes, etc. across the county.

**ESB Ardnacrusha Emergency Services Familiarisation Day**  
On the 21st of February last, representatives from Clare County Fire & Rescue Service had the opportunity to attend an Emergency Services Familiarisation Day held at Ardnacrusha Hydro Electric Station. This was a multi-agency event which focused on giving the emergency services who attend emergencies at Ardnacrusha the chance to meet and familiarise themselves with the Dam and its infrastructure in the event of an emer-

agency such as Fire in the Hydro Station, Confined Space Rescue, Water Rescue, Injury on the Embankment, etc.

The groups that were represented on the day were from: Clare County Fire & Rescue Service; Limerick Fire & Rescue Service; An Garda Síochána; HSE; Irish Coast Guard; Irish Army and Clare Civil Defence. Many thanks to Declan Quille, Civil Engineering Manager at ESB Ardnacrusha Generating Station for hosting this very beneficial event.

### Gardening

Imbolg (St. Brigid's Day) has traditionally been heralded as the start of Spring, and with milder temperatures and an increase in daylight hours, the Gardening Team have been busy preparing early season bedding plants.

Hanging baskets have been prepared in advance of hanging before St. Patrick's Day festivities, while spring flowering bulbs have been planted to bring a colourful burst at locations around Áras Contae an Chláir.



While focus now shifts to a new growing season, in early February the team undertook the shredding of 1,000 Christmas trees which had been dropped off by householders to the Gardening Depot during January. This wood chip will be used by Gardening in the coming months as a natural weed suppressant and soil improver, as the material breaks down and releases nutrients into the soil.



The Gardening Team also continue to engage with and assist community and tidy town groups. During February, the team engaged with Kilrush Tidy Town to advise and assist in the preparation of spring bedding plants, that the tidy town group will plant at various locations around Kilrush Town in April and May.

**Annual Drinking Water Returns - Public and Private GWS and Commercial Private Supplies**

In accordance with Section 58 of the Environmental Protection Agency Act, 1992, Clare County Council are required to submit the 2024 annual drinking water monitoring returns for private drinking water supplies. All 2024 drinking water monitoring data was uploaded and submitted through the Environmental Data Exchange Network Monitoring Data System (EDEN-MDS) by the deadline of 28th February 2025. Drinking water supply details must also be updated in EDEN for the 2024 reporting period by 28th February 2024. We have complied with all statutory obligations in this regard.

**Agriculture Inspection Programme:**

All farms inspected during 2024 have been listed in required format for submission to the EPA by the annual February deadline.

**Local Authorities Waters Programme**

Clare County Council hosted the quarterly South Western Regional Water & Environment Management Committee meeting in February. This forum provides an opportunity for member Local Authorities to discuss the requirements of the Water Action Plan and Local Authority Strategic workforce planning requirements. The role of LAWPRO and Local Authorities are set out to promote the improvement mechanisms for the receiving envi-

ronments. The meetings are chaired by Clare County Councils Chief Executive.

**Waste Enforcement**

**Environmental Monitoring (Illegal Dumping/Litter)**

The Waste Enforcement Team continued to respond to waste and litter related complaints in February. A total of 87 complaints relating to litter (6) and waste (81) were received in February. All of these are currently being investigated, followed up and appropriate enforcement action will be taken.

**Multi-Agency Meeting**

The Q1 2025 meeting of the Regional Multi-Agency Forum took place in Cork on February 13th. In attendance were members of An Garda Síochána, Waste Enforcement Regional Lead Authority (WERLA), National Parks and Wildlife Service (NPWS), Revenue and other local authorities. Multi-agency checkpoints are planned for Q1, where the Gardai will lead, and members of the Waste Enforcement team will inspect vehicles for relevant waste authorisations.

**Fines issued under the Litter Pollution Act 1997, As Amended**

A total of 7 litter fines were issued in February, under the Litter Pollution Act, 1997. Appropriate time will be provided for payment, thereafter reminder letters are issued.

**Staff Training**

Staff from the Waste Enforcement team attended training on Environmental Inspection Skills on 21st and 22nd of February, to assist staff when carrying out Environmental Inspections.

**Enforcement Notices and Warning Letters**

Three notices were issued in February under Section 14 of the Waste Management Act 1996, as Amended. These are being monitored for compliance.

### Recommended Minimum Criteria for Environmental Inspections (RMCEI)

The Environment Section have completed our Annual RMCEI return for 2024 to the Environmental Protection Agency. This provides a summary of all resources, inspections, monitoring and sampling and enforcement actions undertaken by the Council and it is required to be submitted by the end of February each year. We have also submitted our 2025 Plan detailing the ex-

pected number of inspections to be carried out under each of the following thematic areas: Air, Noise, Waste, Water.

### Earthcheck Audit

The Environment team hosted the Earthcheck Auditor on the 19th and 20th February, where we presented on the wide range of services provided by the team across all thematic areas. The presentation was given in our Laboratory where we provided insight to the operations undertaken and how they enhance the local environment and provide a sustainable future for residents and visitors alike. We then gave the Auditor a tour of our Central Waste Management Facility in Inagh and showcased our recently developed Integrated Constructed Wetlands, which enhances the local biodiversity.



## CLIMATE ACTION

### Community

The Climate Team at Clare County Council partnered with Ennis Tidy Towns to host a Tidy Towns Networking event on February 12th in the Civic Room of the Buttermarket Building. Tidy Towns Groups from across the county attended to network and build capacity. Councillor Mary Howard opened the evening with a welcoming message, addressing feedback from the earlier workshop held in December 2024.

An attendance of over 40 volunteers and community representatives heard presentations from Clare County Councils Climate Action Co Ordinator in relation to opportunities around Tree Week, an over 60's Climate Awareness course and also how community groups can align their work with the UN's SDG's to ensure quality in their submissions for funding applications.

Clare County Councils Environmental Awareness officer presented on the circular economy and opportunities available to Tidy Towns committees in this space whilst our Rural and Community Development officer offered information to the gathering on the role and guidance that they can offer to Community Groups.

The evening also offered an opportunity for Tim Humphries from Tulla Tidy Towns to details aspects of Tulla Tidy Towns work in the area.



Tree Week: To celebrate National Tree Week 2025 the Tree Council of Ireland and Coillte, with the support from the Climate section and Environment sections of Clare County Council, are making saplings available, for free, to voluntary community groups across the county. Any interested group must undertake to plant saplings in a suitable public location, in their own community. Details are available as per the QR code.




**Energy**

In preparation for the upcoming NSAI audit the energy management met on February 13th.

This group is tasked with monitoring energy usage, identifying opportunities to lower emissions and increase energy efficiency across the organisation.

A review of 2024 was presented showing a reduction in overall energy consumption of 38% since the 2009 baseline. This indicates that Clare County Council remains 5% below the glidepath to the target of 50% by 2030.

The annual energy review to the Management Team also took place on 17th February. Existing energy performance was discussed along with potential future opportunities in relation to Solar PV and LED retrofitting. Management Team via the renewed signing of our Energy Policy committed to supporting the delivery of our targets over the next decade.



**Climate Action Plan Implementation:**

There are a number of reporting mechanisms required to be actioned in relation to reporting on Climate Action within Clare County Council. In February, the Climate Action Team reported to the LGMA on a number of indicators relating to the progress of Year one of the Climate Action Plan. As part of our reporting principles outlined in the Climate Action Plan, the Climate Action Team are preparing an Annual Report on Climate Action for the Elected members. This document will give detail on numerous actions that have been progressed since the adoption of the plan.

On a National level, the Climate team are engaged in work-groups around the Local Government Climate Action Charter and around a review of KPIs for Climate Action.

### Rural Water Programme

The Rural Water Office continues to support group water schemes to ensure a robust and sustainable quality and quantity supply of water is available.

The Department has decided to take a phased approach to approval of funding with a focus on water quality issues for the first phase, namely Measures A1, A2, A3, A6 and A7. Funding applications for the Taken in Charge of Public Group Water Schemes under Measure A6 are not part of this first phase of funding. In addition, the Expert Panel is continuing its work in its evaluation of applications received under Measure A4, A5 and A9. We have informed all successful Group Water Schemes.

The Clare Rural Water Programme Office held an update meeting in relation to the Multi-annual Rural Water Programme 2024-2026 with successful schemes. The purpose of this meeting was to update the schemes recommended for funding under Measure A6 Taking-in-charge of group water schemes and assist in the development of a pathway to successful project delivery.

Group Water Scheme Taking in Charge applications continue to be progressed by the Clare Rural Water Team. The Rural Water Team is working with Group Water Schemes in assessing the

need to carry out emergency works and applying to the Department for exceptional urgent capital works for once off funding as they arise.

Applications for Group Water Scheme annual subsidy which is available to fund operational costs of group water schemes providing water for domestic use continues to be processed by this office. All applications under the 'Grant for Improvement Works to a Private Water Supply' under the Rural Water Programme continue to be processed by the Rural Water Team. Post works final inspections for works within the last 12 months are ongoing.

The Clare Rural Water Office has submitted all additional information as requested by the Department by the closing date of the 12th of February 2025 in relation to funding bids submitted on behalf of GWS under the MARWP 2024 – 2026. A meeting of the County Rural Water Monitoring Committee took place on the 17th of February as detailed in the Water Services Act 2007 Part 6. The meeting was attended by elected members, the Irish Creamery Milk Suppliers Association, Irish Farmers Association, Clare Federation of GWS, National Federation of GWS and the Clare Rural Water Programme Office Staff.

## SHANNON MUNICIPAL DISTRICT

---

### Visit to St Gabriels Respite Centre

St. Gabriel's Foundation is a not-for-profit organisation and registered charity founded in 1961. They provide a range of essential services and education to children with disabilities and their families in the Mid-West. Two thousand children with varying levels of disability attend their services, which include St. Gabriel's School, Hydro pool, Respite House, Orthotics Department and two Clinical Disability Network Teams.

Treasa McAuliffe, CEO of St Gabriels Respite Centre, welcomed Shannon Municipal District staff to their respite facility. Their facility caters for children with complex medical needs, and it is currently the only facility of its kind outside of Dublin. It currently serves the Mid-Western Health Board's CH03 area which includes North Tipperary, Limerick and Clare.

We look forward to working in partnership with St Gabriels to facilitate an extension of their service across our Municipal District.



### Storm Éowyn Response

Shannon Municipal District maintenance crews worked with Shannon Fire Service, ESB Networks, EIR and Uisce Eireann to remove fallen and damaged trees from the public roads in the Municipal District. This work was completed within two days after Storm Eowyn. However, the amount of damaged and fallen trees that required to be felled and cleared in the public area was significant. Additional resources from the private sector were utilised. This work has continued and should be completed by the end of February.



## PHYSICAL DEVELOPMENT

Two satellite community hubs were setup in the Shannon MD for local level response to the needs of people who have been significantly impacted by Storm Éowyn. The hubs provided people with basic needs such as water, phone charging facilities, broadband, showers and information on how to source a hot meal or other requirements across the district.
