 - a) the proposed development under Section 179 of the Planning and Development Act 2000, as amended, to include a public car park on green field site in the village centre of Bodyke to include: Provision of vehicular and pedestrian access from the R352 roadway via alterations to existing access; Provision of additional pedestrian access to the

car park from the adjacent Bodyke Community Park; Provision of cycle parking and repair station; and ancillary works, and

Cllr. Hayes in introducing the item remarked on the significance of bringing a Part VIII Local Authority Development Application to a Clare County Council Municipal District for the first time. He indicated that this is the first time the members of a Municipal District will be exercising their reserved function at MD level for this function - democracy being implemented at a local level.

Cllr. Hayes asked Brian McCarthy – Senior Planner and Killaloe MD Coordinator to provide the members with an overview of the Chief Executive's Report, which he did.

The Chief Executive's Report and the proposed development were considered by all Elected Members and in the absence of any amendments to the report or the proposed development the Part VIII was deemed to be adopted.

In proposing the motion Cllr. T. O'Brien thanked Brian McCarthy – Senior Planner & Declan Flanagan – A/Senior Executive Engineer for bringing this before the meeting. This is another positive *cog in the wheel* of East Clare enhancement and upgrade to Municipal District.

In seconding the motion, Cllr. P. Burke welcomed the initiative in East Clare, this will improve connectivity, utilising the Local Link Bus.

Cllr. Hayes continued to remark on the importance of this Part VIII Application for Bodyke Village Centre and the enhancement of local democracy decisions at MD level both of which are in line with the objectives of the *Elected Members of Killaloe Municipal District - Strategy and Work Plan 2025-2029*.

Cllr. C. Ryan, fully supports this development, adding that this was a fantastic development for the village of Bodyke with all services integrated.

Cllr. A. O'Callaghan, thanked everyone for getting this to Part 8, something we want in every village, to integrate all the services.
